PUBLIC INVITATION  
to tender for an open public procurement procedure for  
signalization equipment and protection and safety equipment for ski resorts,  
procurement number 24/09

Public enterprise "Ski Resorts of Serbia" invites all the interested bidders to submit their bids for this public procurement in accordance with the conditions stated in this public invitation and the tender documents.

The subject of this invitation is public procurement of signalization equipment and protection and safety equipment for ski resorts (signs posts, poles, sticks, safety nets and protective coatings). Detailed technical specification for this public procurement is given in the tender documents.

The right to bid for this public procurement tender is granted to all the interested parties that comply with the obligations necessary to participate in a public procurement procedure stipulated in Article 44 of the Law on Public Procurement, and they prove such compliance in the manner stipulated in Article 45 of the Law on Public Procurement, in accordance with the tender documents which define the terms and conditions in greater detail.

When choosing the best bid, the governing criterion shall be the economically most advantageous bid, and the elements of the criterion are as follows:

1. Price ..... 70 ponders
2. Guarantee period for the equipment ..... 20 ponders
3. Delivery time ..... 10 ponders

The interested parties can have a direct insight into the tender documents and take the tender documents every business day from the day this public invitation is published in the "Official Gazette of the RS" until the deadline for submitting the bids is expired, in the period between 10.00 and 14.00 hours at the premises of the PE "Ski Resorts of Serbia", the address being Milutina Milankovica 9, level 4, New Belgrade.

In order to take the tender documents, a domestic bidder shall pay an irrevocable amount of RSD 2,000.00 to the procuring entity's current account no. 205-124079-40 opened at Komercijalna banka a.d., the purpose of the payment shall read "Buying Tender Documents for the Public Purchase of Signaling Equipment, no 24/09".

In order to take the tender documents, foreign bidders shall pay an irrevocable amount of EUR 20 to the foreign currency account of the PE "Ski Resorts of Serbia" opened at Komercijalna banka a.d., the instructions being as follows:

The tender documents can be taken upon presenting an evidence that the irrevocable amount for taking the tender documents has been paid and also by submitting an authorization letter for the bidder's representative who takes the tender documents.

The deadline for submitting the bids is 30 days upon announcing this public invitation in the "Official Gazette of the RS" until 12.00 hours. The bids shall be submitted in sealed envelopes to the following address:

In case that the last day of the deadline is not a business day, the last day of the deadline shall be the first business day following that day.

The bids that do not arrive at the procuring entity's address until the above stated day and hour shall be considered untimely bid and, upon closure of the bid opening procedure, such a bid shall be returned to the bidder unopened.

Bids can be submitted in person or via post office.

Bids shall read "Bid for the Public Procurement of Signaling Equipment and Ski Runs Marking Equipment, procurement number 24/09 – do not open", and the back of the envelope shall have the bidder's name and address.

A bid must be valid for at least 60 days from the day of opening the bids.

Bid opening is public.

Public bid opening shall be done the same day when the deadline for submitting the bids expires, at 12 hours and 30 minutes, at the premises of PE "Ski Resorts of Serbia" at their address Milutina Milankovica 9, level 4, New Belgrade.

Authorized representatives of the bidders can be present at the bid opening. Their written authorizations for the participation in the bid opening procedure, stamped and signed by the authorized person, shall be submitted to the Public Procurement Committee before the bid opening procedure begins.

The procuring entity shall make the decision on the best bid within 30 days from the day of the public bid opening procedure and shall deliver such decision to all the bidders not later than three days upon making the decision.
