PUBLIC INVITATION

For the submission of bids in open procedure of public procurement for the relocation part of the equipment of fixed 4-seat chairlift Karaman greben on the location Suncana dolina, with the purchase of missing equipment, services and works for building fixed 4-seat chairlift Suncana dolina in the ski centre Kopaonik (equipment, services and works), number of procurement 9/2010

Subject of the public invitation is relocation part of the equipment of fixed 4-seat chairlift Karaman greben on the location Suncana dolina, with the purchase of missing equipment, services and works for building fixed 4-seat chairlift Suncana dolina in the ski centre Kopaonik (equipment, services and works). Detailed specification of the subject of public procurement is within the bidding documents.

All interested domestic and foreign bidders that fulfill compulsory conditions according to the Article 44 and Article 45 of the Law on Public Procurement and other conditions defined by the Bidding documents have the right to participate in the procedure. Bidder is obliged to submit with his offer evidence on fulfillment of these conditions.

Inspection and take over of the bidding documents is possible from the date of announcing the public invitation in the “Official Gazette of RS” on working days from 10,00 a.m. to 13,00 p.m. in the premises of the PE “Ski Resorts of Serbia” at the address Milutina Milankovica 9, 4th floor, New Belgrade.

For taking over the bidding documents local bidders shall pay the amount of 15.000,00 RSD to the account of Public enterprise „Ski resorts of Serbia“ number 205-124079-40 with Komercijalna banka a.d., purpose of payment „Public procurement relocation part of the equipment of fixed 4-seat chairlift Karaman greben on the location Suncana dolina, number of procurement 9/2010“.

Foreign bidders shall pay the amount of 150,00 EUR to the account of Public enterprise „Ski resorts of Serbia“ according to the payment instructions:

Paid amount is non-refundable and any bank charges and fees shall be paid by the bidders.

Bidding documents can be taken over by the Bidders authorized person with written authorization for taking over the bidding documents and with presentation of the evidence of payment.

The term for submitting bids is 22 days from announcing the public invitation in the "Official Gazette of RS" until 10 a.m. Bidder is obliged to submit to Orderer bid and a copy of bid in two separate envelopes. The bidder guarantees that the copy is identical to the bid. Bids are submitted in a closed and sealed envelopes to the address:

In case that the last day of the term is not a working day, then the first next working day will be considered the last day of the term.

A bid from a bidder that has not reached the Orderer until the referred day and hour will be considered as late and such a bid will be returned to the bidder unopened after finishing of the procedure of opening bids.

Bids may be submitted in person or by registered mail.

Bids must be marked "Bid for public procurement relocation part of the equipment of fixed 4-seat chairlift Karaman greben on the location Suncana dolina, number of purchasing 9/2010 – do not open", and on the backside of the envelope, there must be the name and address of the bidder.

The Bid must be valid at least 60 days from the day of opening the bids.

Opening of bids is public.

Public opening of bids will be performed immediately after termination of the term for submitting bids, i.e. on the last day of the term at 10:30 a.m. in the premises of the PE "Ski Resorts of Serbia" at the address Milutina Milankovica 9, 4th floor, New Belgrade.

Authorized representatives of the bidders may be present at opening of bids, who will submit their written authorizations, verified with seal and signature of the authorized person, for participating in the procedure of opening of bids to the Committee for public procurement before the beginning of opening bids.

The criterion for selection of the most favorable bid is the most favorable bid with the following elements:

- 1. Price**
- 2. Warranty period**
- 3. References**

Elements of the criteria are described and evaluated in the Tender documentation with quotation of methodology of awarding points for each element of the criteria.

Decision on awarding the contract will be made approximately within 10 days from the day of opening the bids. All the bidders will be informed in written form on the decision.
